Phone Scam Claiming Bogus Tax Bill

Thieves are going to extremes to get your money. They are calling and claiming they are the IRS saying the taxpayer owes a huge bill. They will accept debit card or wire transfer, but you must remember the real IRS will not demand money over the phone or by email. The IRS will send tax bills through mail. Get An Identity Protection PIN (IP PIN)

Stop the misuse of your Social Security number on fraudulent tax returns by requesting an IP PIN from the IRS. Verify your identity with an email address and they will send a six digit pin number to provide your tax preparer(us) at the time of your e-file signature.
